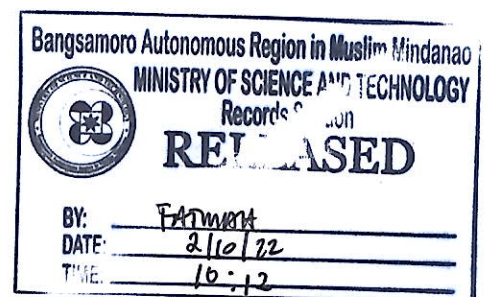
As such, the above named members of the newly hired reconstituted HRMPSB shall assess, evaluate and recommend the most qualified candidate for promotion and or selection for appointment, in accordance with existing Merit Selection Plan (MSP) and SRP of the office and in concurrence with rules, regulations and laws of the Civil Service Commission. The term of office of the said members shall be good for two (2) years subject to existing CSC Laws on Appointment and Other Human Resource Action.

The board shall be joined by one representative from the Office of the Chief Minister as per OCM Administrative Order No. 002 series of 2020.

This Special Order takes effect as above stated and shall remain in full force and effect unless superseded and/ or revoked by competent authority.
