The Book of Accounts of the Ministry revealed an accumulated Outstanding Cash Advances which remain to be Unliquidated as of October 25, 2024 amounting to **P 473,624.00**, the details of which is found in the attached Annex A.

That, to preempt the unnecessary existence of the abovementioned Outstanding Cash Advances in the CY 2024 Financial Statement, all employees and officials of the Ministry are directed to liquidate their respective outstanding Cash Advances immediately pursuant to Sec. 89 of Presidential Decree (PD 1445), which states that a cash advance shall be reported on and liquidated as soon as the purpose for which it was given has been served.

That, failure of the accountable officer to liquidate his Cash Advance shall cause for the suspension of his salaries, and administrative proceedings shall likewise be instituted, pursuant to the provisions of PD 1445 and CSC Rules and Regulations.
